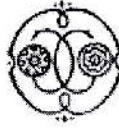

A. General condition of Tender

1. This is only a Techno-Commercial inquiry and not an order.
2. The intending tenderers are advised to visit the site and examine thoroughly the site condition etc. before submitting the tender. Non familiarity with the job & others will not be considered reason either for extra claims or for not carrying out the work in strict conformity with the specifications.
3. Bids are invited from reputed agencies to carry out the job as described above in the description box Interested Agencies meeting the Eligibility Criteria can submit their Bid Documents off-line i.e. in the Tender Box placed in Calcutta Club.
4. Site address: Calcutta Club Ltd, 241, A. J. C. Bose Road, Kolkata 700 020.
5. Any query on the matter should be sent to us through email only as mentioned in contact details , with the subject line, (Name of work) at least 3 working days before Closing date..
6. Sealed Tender to be submitted in two BID (1) Technical Bid with all related documents (2) Price Bid with GST shown separately. **(Price bid to contain only the Bill of quantities of Annexure 1 with rates duly filled in.)**
7. Two BID documents in two separate sealed envelopes, Technical Bid & Price Bid, to be placed inside a sealed envelope subscribing **"New Deep Tube Well Construction."**

B. Special Condition Of Tender :

- 1) **Site Particulars :** Intending bidders shall be deemed to have visited the site and familiarised themselves with the site condition.
- 2) All materials supplied under this tender will be kept under executing agency's custody till completion and Handing over.
- 3) Installation work may be carried out during in operational timing as per direction of authority so that club's regular activities are not affected.
- 4) All installation hardware and consumables are in vendor's scope.
- 5) Repair and refinishing of holes/damages/chipping are in vendor's scope.
- 6) **Extra Item of Work :** During execution should the contractor come across any items of work not covered under schedule of rate, contractor shall draw attention of club authority and obtain prior approval before taking the extra items executed.
- 7) **Construction Safety :** Construction safety norms are to be strictly followed while working inside club premises such as safety helmet , Glow sign jackets, identity card, body harness etc. To be used by all labourers engaged by the contractor as per nature of the job.

C. Payment Schedule :-

Monthly on account bills would be paid within a fortnight from the date of submission. Final bill will be paid within two to three months from the date of submission. 10% Retention money will be kept till successful commissioning in all respect which is subject to not more than 12 months.

In case of delay in completing the work due to reasons solely attributable to the contractor, delay penalty will be imposed at the rate of 0.5% per week or part thereof up to a maximum of 5% of contract value.

D. Pre-Qualification Compliances:

The bidder must submit the copies of the following documents in the Technical bid cover, relating to the status of their firm and should produce the original for verification on demand:

1. PAN Card
2. GST Registration Certificate
3. Recent Trade License
4. Recent Contractor's License for conducting the described job.
5. Valid PF Registration Copy with recent challan copy
6. Valid ESI Registration Copy with recent challan copy
7. The bidder should have successfully executed work of similar nature during past five (05) years. List of such WO along with customer's satisfactory execution confirmation to be submitted along with the tender.

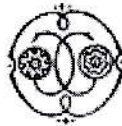
Amendment to Tender Document:

Any amendment/corrigendum on subsequent date, if any will be displayed on web site of Calcutta Club .

E. Earnest Money:-

EMD/ Cheque of Rs. 8,000.00 to be provided along with the Technical bid through a Demand Draft / Cheque in the name of " Calcutta Club Ltd ".

Earnest money will be forfeited if the awarded contractor do not commence the work within 15 days from the award date.

F. Security Deposit:-

10% of each Running Account Bill amount will be deducted as Security deposit after adjustment of EMD received and Earnest money will be converted into initial Security Deposit. Security Deposit will be refunded after 12 months from the date of completion, i.e., on completion of defect liability period (12 Months).

G. Submission of Bids

- Bids must be submitted in a sealed envelope super scribing the tender name “**New Deep Tube Well Construction.**” and addressing To The CEO , Calcutta Club, 241 A.J.C Bose Road , Kolkata – 700020 , and submit the same along with Bid document within the specified date & time.
- Calcutta Club, at its own discretion, may extend the deadline for submission of the bid, notification of which will be given on its web site. In such scenario, bidder may submit their bid as per the extended deadline.
- Late Bid: Not acceptable.
- Bids will be submitted in two parts – I. Technical consisting of prequalification compliances along with signed tender document minus Bill of quantities, duly filled and signed, II. Price Bid:- showing separately GST.
- In case work order is awarded to the successful bidder and he is unable to execute/complete within the specified time , earnest money will be forfeited / 0.5% will deducted as liquidity damage every week maximum up to 5%.

H. BID Opening and Evaluation:

1. BID Opening :

Bids will be opened on the due date and stipulated time in presence of Committee Chairperson.

Confidentiality of Bid Evaluation Process:

- a. Information relating to examination, evaluation and comparison of Bids and recommendation of award of contract shall not be disclosed to the Bidders or any other interested party. Any effort by the Bidder to influence the bidding process may result in rejection of their Bid.

2. Correction of Errors :

- a. Bids which have meet all tender terms and conditions will be checked for any arithmetical errors. Errors will be corrected by Calcutta Club in the following manner :-
 - i. Where there is discrepancy between amount in figure and amount in words, the amount stated in word will be considered for the purpose of evaluation and Unit rates of each items will be taken into consideration.

3. Evaluation and Comparison of Bids :

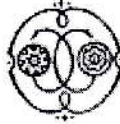
Bidder must quote for all items and exactly as sought in the PRICE BID. Any deviation will result in rejection of Bid.

I. Award of Contract

- 1. Work order/ Letter of Acceptance will be issued to the successful bidder. Earnest money will be refunded to the unsuccessful bidders immediately thereafter.
- 2. Calcutta Club reserves the right to accept any Bid or reject any /all the Bids at any time prior to the award of contract without assigning any reason to the Bidders or incurring any liability to the affected Bidder(s).

K. Corrupt & Fraudulent Practices:

1. Calcutta Club requires the bidders/contractors to maintain highest standard of ethics during the bidding process as well as execution of the contract. Definition of corrupt and Fraudulent practices is as follows:-
 - a. "Corrupt practice" means offering or giving anything of value to influence the Club official in procurement process or contract execution.
 - b. "Fraudulent practice" means misrepresentation of facts to influence the procurement process or execution of contract to the detriment of Calcutta Club.
2. Bidders are required to furnish complete and correct information required for evaluation of Bid. If the information/ documents forming part of the Bid is found to be false or forged the same shall be sufficient ground for rejection of Bids. In case, the information/ document submitted by the successful Bidder is found to be false/forged after the award of the contract, Calcutta Club has full right to terminate the contract and get the remaining part of the contract executed at the risk and cost of such agency/ contractor without any prejudice to any other right available to Calcutta Club such as withholding payment etc. Earnest money and Security Deposit will be forfeited in such cases.

L. Vendor's undertaking:

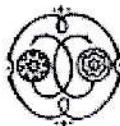

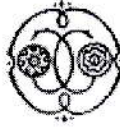
